Jackson Convention—At a convention held in the Representative Hall of the State House in Indianapolis, on Tuesday the 8th day of January, 1828, the Convention was called to order, when,

On motion of William Marshall of Jackson county, ISRAEL T. CANBY was appointed President, and BENJAMIN V. BECKES Vice President of the meeting.

On motion of Mr. Judah, William Marshall and Paris C. Dunning, were appointed Secretaries.

Whereupon, the following gentlemen produced their credentials and took their seats as members of this Convention, viz:

On motion of Mr. Givans, *Resolved*, That those members of the Legislature who have not been delegated to this convention, but who are friendly to the election of GENERAL ANDREW JACKSON to the Presidency of these United States, be admitted as members of this convention.

Whereupon, the following gentlemen came in and took their seats:—Eliphalet Allen, of Parke; John M. Lemon and Joseph Work, of Clark; William Lewis of Union; Elsha Long, of Henry; Madison, &c—H. McPheters, of Washington; William Campbell, of Switzerland; James G. Reid, of Daviess; Enos Blair, of Monroe.

William Hoggett of Orange, was admitted to a seat by the convention.

On motion of Mr. Samuel Milroy, *Resolved*, That the rules of parliamentary proceedings, be adopted as the rules for the government of this Convention during its session.

On motion of Mr. Pollock, *Resolved*, That Messrs Clendenin and Boon of the 1st Judicial Circuit; Marshall & Stewart of the 2d; Smiley and Armstrong of the 3d; Givens & Fitzgerald of the 4th; and Ketcham & Cain of the 5th, be appointed a committee to prepare an Electoral Ticket composed of one elector for each Judicial Circuit in this state.

On motion of Mr. Boon, *Resolved*, That a committee of five be appointed by the President to prepare an address to the people of Indiana, on behalf of this convention,

Whereupon, Messrs Judah, St. Clair, Dun-

ning, Willitt, and Fitzgerald, were appointed that committee.

On motion of Mr Judah, *Resolved*, That this convention adjourn, to meet again in the Senate chamber, at 6 o'clock, which passed, and the convention adjourned.

SENATE CHAMBER, 6 o'clock, P. M.—The convention met pursuant to adjournment.

On motion of Mr J Milroy, *Resolved*, That a committee of two delegates from each Judicial Circuit be appointed, to examine and report what measures may be necessary to be adopted by the convention for the purpose of advancing the election of *gen. Andrew Jackson*, to the Presidency of these United States, and that it be the duty of said committee to report to this convention the names of proper persons to constitute a central Committee of Correspondence, and such other committees as may be deemed necessary throughout the state, whereupon—

Messrs Reid and Clendenin, of the 1st Circuit; Lemon & Ross of the 2d; Spencer & St. Clair, of the 3d; Fitzgerald & Givens of the 4th; Aldridge & Lee of the 5th, were appointed that committee.

On motion of Mr. S. Milroy, *Resolved*, That a committee of three be appointed to make arrangements for printing such documents as may be determined upon by the convention, whereupon—

Messrs, Milroy, Cain and Boon, were appointed that committee.

INDIANAPOLIS, January 12, 1828.

Administration Convention.—This being the day originally appointed for the meeting of the friends of Home Manufacture and Internal Improvement, in the state of Indiana, at Indianapolis; with a view of consulting how those interests may best be promoted. There were present as delegates chosen by several of the counties the following persons, to wit:

The following persons from the various parts of the state of Indiana, friendly to the present administration of the general government, and favourable to a system of internal improvement, being invited by the delegates aforesaid, took their seats as members of this meeting, to wit: from the county of Wayne, Jas. Rariden, Wm. Steele, Abel Lomax, William Elliott, John Jones and Isaiah Osborn; from the county of Dearborn, Ezekiel Jackson and James Dill; from the county of Clark, John S. Simonson, Isaac Hawk and John H. Thompson; from the county of Washington, M. G. Clark, John H. Farnham, and Henry P. Thornton; from the county of Switzerland, William Cotton and Stephen C. Stevens; from the county of Jefferson, John L. Spann, and Jas. F. D. Lanier; from the county of Fayette, N. Claypool and Israel Decamp; Union, T. Brown; Rush, Amariah Morgan, C. H. Veeder and William Newell; Decatur, Thos. Hendricks; Ripsey, M. S. Craig; Jackson, William Grayham; Floyd, John K. Grayham; Crawford, Seth M. Levenworth and Allen D. Thom; Lawrence, Rollin C. Dewey; Posey, Samuel Annable; Vigo, John M. Colman; Vanderburgh & Warrick, Charles M. Johnson; Perry, John Daniel; Montgomery, John Beard; Parke, James Blair; Shelby, Jas. Gregory; Johnson, John Smiley and Peter Dewit; Randolph, Daniel Worth; Allen, Samuel Hanna; and from Bartholomew county, Benj & Philip Sweetser.

John Watts, an old revolutionary soldier, was chosen to preside at the meeting, and James Dill and Henry P. Thornton, were chosen secretaries.

On motion of Mr. Wilson, *Resolved*, That the credentials of the delegates be submitted to a committee to report thereon, and Messrs. Wilson & Morris of Marion were appointed that committee.

On motion of Mr. Montgomery, *Resolved*, That a committee of thirteen persons be appointed to draft an address to the people of this state on the subject of the next presidential election, and that said committee report at the next meeting; and Messrs. Law, Harrison, Farnham, Morris, Sharp, Rariden, Maxwell, Bassett, Hawk, Grayham, Moore, Sweetser and Craig were appointed.

On motion of Mr. Maxwell, *Resolved*, That a committee of three persons from

each Judicial Circuit in this state be appointed to inquire into the expediency of recommending an electoral ticket friendly to the present administration, and report thereon at the next meeting; and if they deem the same now expedient, that they accompany their report with the names of the persons selected by them to compose such electoral ticket; and thereupon, the following gentlemen were appointed that committee, to wit: Messrs. Anson, Colman and Beard, of the 1st Circuit; Lane, Clark, and Simonson, of the 2d; Watts, Daniel, Worth, & Reid, of the 3d; Montgomery, Daniel, and Johnson, of the 4th; Morgan, Smiley, & Gregory, of the 5th,—and the meeting adjourned to meet in the representative hall, at 6 o'clock on Monday evening next.

On Monday evening the convention assembled, and Milton Stapp from Jefferson county, appeared as a delegate duly appointed; and Seth M. Levenworth and Allen D. Thom, from Crawford county, produced their credentials. Isaac Hurlock, of Hamilton county, appeared and took his seat as a friend of the administration; and John M. Colman, from Sullivan and Clay, and Thomas J. Matlock, from Morgan, took their seats as delegates;—and the following report was submitted from the committee on the subject of forming an electoral ticket, to wit:—

The committee to whom was referred the resolution of this convention, adopted on the 12th inst. to take into consideration the propriety and expediency of forming an electoral ticket favorable to the re-election of *John Q. Adams*, to the presidency of the United States, beg leave to report:—That the members composing said committee, met and interchanged opinions on the subjects referred to them by the convention. That they are fully aware of the difference of sentiment on this subject, arising out of the unfortunate circumstance of a change in the time originally agreed upon for the meeting of the delegates; but your committee, under all the circumstances, are of opinion that an electoral ticket should be formed, and presented to the people as soon as possible.

The fact of 71 delegates & friends of the administration, from 41 counties, having met on the day originally agreed upon, is a circumstance worthy of consideration, and is one amongst the many reasons which have governed your committee in recommending the formation of an electoral ticket at this time. It is the opinion of your committee, that the friends of the administration, & of the American system in the counties which are represented, as also those represented by friends not regularly delegated, would most cheerfully accord with, & co operate in such measures as may be agreed upon by the present convention. The circumstances under which it has taken place being explained, it is believed that no objections would arise to any arrangement which may be made by this convention, which might further the views of the friends of the administration, and have a tendency to promote the cause in which we are engaged. Under this view of the subject, your committee recommend the adoption of the following resolution:

Resolved, That general Joseph Orr, of Putnam county; honorable John Watts of Dearborn; gen Joseph Bartholomew of Clark; honorable Isaac Montgomery, of Gibson; and the Rev James Armstrong, of Monroe, be recommended to the people of Indiana, as suitable persons to compose the administration electoral ticket of the state of Indiana. The convention then adjourned to Wednesday evening.
