STATE BANK.

VINCENNES BRANCH.

An error occurred last week in publishing the list of Directors to this Branch, to correct which, the names of the Directors are again published:—

David S. Bonner, William Borch, Robert Smith, Nicholas Smith, John F. Snapp, Mathias Rose, William Raper, and Samuel Wise; who, together with John Law, John Wise, and Samuel Emison, as Directors on the part of the State, will compose the board of Directors of this Branch. David S. Bonner was unanimously elected President, John Ross, Cashier, and Michael Murphy of Washington, Daviess county, Indiana, Director of the State Bank, on the part of this Branch.

INDIANAPOLIS BRANCH.

We are gratified to be able to state that the full amount of the subscriptions of Stock, on the part of the Stockholders of the Branch at this place, was punctually paid in, on Monday last, without any deduction. Considerable anxiety was also manifested for the purchase of stock, and a small premium offered.

On Tuesday, according to previous notice, the election for Directors took place, which resulted in the selection of the following gentlemen, viz:

Harvey Bates, B. I. Blythe, Samuel Henderson, John Wilkins, David Williams, Alexander W. Russell, Homer Brooks, James Blake.

The Directors have appointed Mr. HERVEY BATES, President, and the Hon. B. F. MORRIS, Cashier. The salary of the Cashier, we learn is fixed at eight hundred dollars per annum. Samuel Herriot, Esq., is appointed the Representative in the Indianapolis Branch, in the State Directory.

The Governor, we understand, expects to be able to issue his Proclamation for the Bank to go into operation in about ten days.

LAFAYETTE BRANCH.

On Monday last, the last day for the payment of the first instalment of the Bank stock, the Stockholders came forward with great punctuality; and we learn there were but few delinquents, and that their stock was taken up and paid in very readily.

On Tuesday, the Stockholders proceeded to elect their Directors for this Branch, which occupied the whole day, and resulted in the election of Messrs. WARASH INSURANCE COMPANY.—The annual election for Directors of the Vincennes Insurance Company took place on Monday the 17th inst, when Samuel Judah, Jos. Simes, Thos. C. Baily, H. D. Wheeler, J. B. Martin, Samuel Colman, John I. Neely, Chas. Polke and Samuel Bruner, were elected. At the first meeting of the Directors, Samuel Judah was re-elected President, and Alexis Le Roy Secretary. I have been informed a dividend of 25 per cent. was declared upon the stock paid in. I can truly say, the institution has been well managed, and the dividend declared, shows it to be profitable to the stockholders.

Wabash and Erie Canal.—Water was let into the summit section of this canal yesterday, from the St. Joseph River.—Five miles of the canal are now ready for navigation, and an additional portion of 8 or 10 miles will be filled in a few days.

H. D. Gilpin has been appointed governor of the Territory of Michigan, in the place of George Porter, Esq. deceased.

CIRCULAR.

To the Collectors of the Customs and all Receivers of Public Money.

Whereas, by the act of Congress passed 31st July, 1789, it is provided "that the duties and fees to be collected by virtue of this act, shall be received in gold and silver coin only" and, by a usage under that act and a similar one, as to the payment for public lands, it was customary to receive only specie and the notes or bills of Banks redeemable in specie, until 1814; and after a different practice, adopted in 1814, Congress, on the 30th April 1816, resolved, "That from and after the 20th day of February next, no such duties, taxes, debts, or sums of money, accruing for becoming payable to the United States, be collected or received otherwise than in the legal currency of the United States, or Treasury notes, or notes of the Bank of the U. States, or in notes of Banks which are payable and paid on demand, in the legal currency of the U. States." And whereas, the practice under that resolution, conformed to its provisions, till January 21st, 1828, when permission by this department, under certain assurances from the Bank of the United States, was given that drafts or checks of the Bank & its branches, should be received for the public dues; though said drafts or checks were not notes of the Bank, not being like notes, signed by the President and Cashier thereof, nor originally made payable to bearer; nor, according to the subsequent decision of the Supreme Court, coming within the description of a note or bill.—And whereas Congress have never authorized the issuing such drafts for the purpose of circulating as currency, and have refused, though urgently and repeatedly requested to permit the issuing of notes of the Bank of the smaller denominations, so signed; and the great extent to which the said drafts of small denominations have been put in circulation, as currency, seeming to be directly repugnant to the spirit of the act incorporating the Bank, and of the subsequent proceedings of Congress; and doubts having arisen as to the legal liability of the Bank, to redeem the said drafts in specie, under the penalty provided in the charter for the non-payment of "its bills notes or obligations;" and the counterfeits of the said drafts having become very numerous, and difficult of detection, and those who sell or utter them, being likely to escape punishment, in consequence of questions which arise in prosecuting them under the said charter, it is therefore, deemed proper, in order that the clearly expressed views of Congress should be enforced, and the agents of the Department protected from the risks and losses by said drafts, to revoke the permission granted in 1828; but with a view to give due notice to the community and Bank, of the contemplated change, not to allow the revocation to take effect till the period hereafter mentioned.

Hence, in conformity to the requirements of the aforesaid acts and joint resolutions in Congress, all collectors of customs, and all receivers of public money, are hereby enjoined, that, after the first day of January next, they shall not receive in payment of duties or of public lands and coin or paper except such as is described in said resolutions, viz "the legal currency of the United States, or Treasury notes, or notes of the Bank of the United States, or notes of Banks which are payable, and paid on demand in the legal currency of the United States."

A friend at our elbow says that for his part, if he were Mr. P., he had rather Old Hickory should enter the arena in any other way than as "plain Andrew Jackson," for in that capacity he's "quite an ugly customer."

Commercial Report.

From B. Levy's Price Current of Nov. 1.

Cotton.—This has been a week of considerable activity in the cotton market; the reviving demand, spoken of in our last, at the close of the week, has since been followed up; and the result is the transfer of a large amount, say 1200 bales, generally, at an advance of from 4 a cent on last week's prices; sales of inferior to second quality, ranging from 134 a 144 and for Prime and Choice, from 15 a 16 cents; and operations limited to the extent mentioned only in consequence of the shortness of the supply. Choice cotton remains scarce.

Sugar.—Sales of both old and new crop (several lots of which have come into market) are made within the range of our quotations, from 4 1/2 a 6 1/2; from all we can learn, the present crop promises to be one of great yield, and the quality of what has been received is very highly spoken of.

Molasses.—A few barrels of indifferent quality still find their way to market.

Tobacco.—We have not heard of the sale a single hhd. this week, and believe there is none offering; it is in good demand.

Flour.—The stock in market is not very large at this moment, but is accumulating; the demand is but moderate at \$1 50 per bbl.; small lots, 4 75.

Pork.—The demand for Pork, though on the increase, is confined to small sales, generally, to fill orders for Planter's use; from \$14 to \$18 50.

Beef is scarce, but the limited demand that continues to be felt renders sales of little importance, and prices without change, from 12 to \$7.

Bacon, though scarce, is not in much request, and the price, except for Hams, which we quote at 9 a 10 cents, without alteration.

Lard.—We quote Lard at 7 a 7 1/2 cents per lb. with a fair supply and rather a dull market.

Whiskey is worth from 30 a 31 cents per gallon; it is still scarce, but not in very great demand.

Lead continues to meet with ready sale on arrival. The last that came in was taken immediately at \$1 314 per 100 lbs. which is, however, a reduction on the previous sale.

Coffee.—The demand for good green coffee is quite active, while other sorts are almost entirely neglected. Present quotations for Havana green 12 a 13 1/2 cents.—No St. Domingo in the place.

Corn is now selling in the ear per bbl. at 87 1/2 cents; shelled in sacks at 75 cents per bushel.

Hay.—From the number of late arrivals, has been quite plenty. We quote cargo sales at 75 cts per 100 lbs.

Oats have declined in price and are now selling for \$1 25 per sack of 2 bushels.

Lime, Thomaston, in considerable quantities, has lately arrived, and is now selling for \$1 75 a \$2 per cask.
